

**Need to deliver judicial and extrajudicial documents in Lithuania?  
Since 2016, Judicial Officers are serving these documents!**

**Document delivery service (in French “signification”) in the territory of the Republic of Lithuania has been delegated to the judicial officers (bailiffs) from the courts.**

**There are the documents to be served, falling within the scope:**

- Of Regulation (EC) No. 1393/2007 of the European Parliament and of the Council on the service in the Member States of judicial and extrajudicial documents in civil or commercial matters (service of documents);
- Of the 1965 Hague Convention on the Service Abroad of Judicial and Extrajudicial Documents in Civil and Commercial Matters.

**Where to apply:**

- Requests for service of documents and documents in accordance with Regulation (EC) No. 1393/2007 must be sent to the Chamber of Judicial Officers of Lithuania, Konstitucijos ave. 15, LT-09319 Vilnius, Lithuania (Internet site: [www.antstoliurumai.lt](http://www.antstoliurumai.lt)).

The Chamber of Judicial Officers of Lithuania, in accordance with Regulation acting as a receiving agency, commits the judicial officers to serve documents.

- Requests for service of documents and documents in accordance with the 1965 Hague Convention must be sent to the Ministry of Justice of the Republic of Lithuania at Gedimino ave. 30, LT-01104 Vilnius, Lithuania (Internet site: [www.tm.lt](http://www.tm.lt)).

The Chamber of Judicial Officers of Lithuania receive documents from the central body - the Ministry of Justice – and commits the judicial officers to serve documents.

**The fee for service of documents:**

- The fee for service of documents in the Republic of Lithuania (pursuant to the Regulation (EC) and the Hague Convention) is EUR 110 (one hundred ten euro).
